



Dear Parent/Caregiver,

Re: Enrolment Management Plan for Wilsonton State High School

Following a certified process with Department of Education and Training (DET) I wish to advise you that Wilsonton State High School is subject to an Enrolment Management Plan (EMP).

This means, due to the increased population within and around Toowoomba district, our school facilities are no longer able to sustain enrolment growth at our previous rate.

What does this mean for you as you enquire about enrolling your child at Wilsonton State High School? It means that if you are within our defined catchment boundary you are entitled to an interview for enrolment. Our office staff will have advised you if you are within our catchment boundary and prior to progressing to interview, proof of residency via the options described overleaf. You will be required to provide:

If you are outside our catchment boundary you are welcome to apply for consideration to enrol your child by:

- Ticking one or more of the boxes overleaf from the list for consideration. I stress that these are areas for consideration and do not represent a guarantee of enrolment
- Providing additional information in writing as to why you wish to enrol at our school which is out of your catchment boundary
- Expression of Interest Out of Catchment Application completed with payment of \$50 non-refundable application fee
- Submitting your full application to our school office staff.

Should your application for consideration be successful you will be invited to an interview. At the time of applying for consideration I strongly encourage you to apply for enrolment at the school within your catchment area.
