The Program

At Wilsonton State High School, students are encouraged to strive for excellence through a personalised learning program that integrates the curriculum and fully encompasses the use of Digital Learning Technologies. Students will have access to their own iPad throughout the course of the day, allowing them to locate information quickly and create products that demonstrate their understanding in all areas of the curriculum. The iPad Purchase program allows students to be able to own a personalised iPad and take it home for learning outside of school hours.

The Curriculum

The teachers of your students' classes will design all learning programs based on the Australian Curriculum. The students will work within these standards in all areas, including English, Mathematics, Science, Humanities, HPE and The Arts. The use of iPads provides students with enhanced access to research, publishing, problem solving, designing, and presenting of their achievements in a fluid and flexible environment. Additionally, students are provided with consistent opportunities to engage in the General Capabilities of the Australian Curriculum – Information communication technology capacity, critical and creative thinking, and personal and social capability.

The Device

- 11-inch Liquid Retina display with True Tone and P3 wide colour.

The iPad will complement learning with other ICT devices across the school. An extensive range of content and creative apps are accessible through the school's software management solution.

Participation Cost

The initial iPad Purchase Program will carry a total cost of \$725.00

iPad A16 (inc. charging cable & power plug)	\$ 520

Upon completion of the Program students may wish to purchase it outright for \$5.

NOTE: If the student leaves the school within the program, the total cost is due and payable prior to the ownership being transferred to personal property.

WILSONTON STATE HIGH SCHOOL iPAD PURCHASE PROGRAM

YEAR 7-12 – iPad to be used for the duration of enrolment at WSHS (**6 years max**)

Option 1 – Full Payment	Option 2 – Instalments	Option 3 – Payment Plan / Centrepay
Full payment of \$725 up front	Payment of \$185 for the first year and \$180 each year for the following 3 years. Payments to be made within 2 weeks of the start of each year.	Deposit of \$50 paid directly to school, then minimum fortnightly payments of \$25 are required via Centrepay, to the total of \$725. iPad will be issued on receipt of first Centrepay payment.

Option 1: Upon leaving and provided that the **total of \$725** has been made, a student may purchase the iPad for \$5. At this time, the iPad will be restored to factory settings and ownership will transfer to the student. **Option 2:** Upon leaving your iPad, case, wall charger and cables are to be returned in good condition.

No refunds, balance owing will be credited from your account.

Enrolments outside of this period

- Where a student and parent/carer are offered a new iPad, a total of \$725 is still to be paid over the period of enrolment or maximum agreement term of 4 years
- Should a second hand (previously used) iPad be available, the student and parent/carer will be offered this at a reduced cost.

Damage

- When an iPad is accidentally damaged, the school will invoice a student's parent or carer \$50
 per incident.
- When an iPad accessory is damaged (keyboard or screen protector). The school will invoice the student's parent or carer the cost of the accessory (as above).
- Where there is **willful and malicious damage**, a student's parent or carer may be invoiced according to the **full amount of repair**.

Theft

If the device is stolen outside of school, the parent/caregiver will need to report the incident to the police and ensure they have the following documentation when informing the school:

- Police crime number
- Statutory declaration (usually completed with the police)

^{*} During the program and while the student is enrolled with Wilsonton State High School, the iPad is non-transferrable.

PAYMENT OPTIONS

1. ONLINE OR BY PHONE: BPOINT - preferred method of payment

BPOINT Online via any Computer or Smart Phone by **Credit Card** at any time 24/7. Just click on the link on an invoice or statement and it will redirect you to the BPOINT option. A receipt will be emailed direct to you at time of payment

<u>Phone payment</u> This option allows you to pay by <u>Credit Card</u> at any time 24/7. Details will be taken by Interactive Voice Response. Visa, MasterCard or Bankcard are accepted. Please have your invoice and credit card details ready when you call <u>1300 631 073</u>.

<u>Note:</u> It is now a requirement that all phone payments be made using this secure BPOINT line, phone payments will no longer be accepted by the school. If you call the school wanting to pay, you will be transferred to the secure BPOINT line. Details are on the bottom left-hand corner of all Invoices and Statements.

2. INTERNET BANKING:

This allows parents/guardians to pay 24/7 over the internet for any outstanding debts listed on your School Debtors Statement. Our school bank account payment details are as follows: -

3. QPARENT:

Payments can be made through QPARENT sign in. This is also a good way to track invoices and payments history at any time. You can also see – attendance details, student timetable and report cards of students. 4. <u>CENTREPAY</u>: Wilsonton SHS Centrepay Organisation Reference Number: 555124954B

Centrepay is a free direct bill-paying service offered to customers receiving payments from Centrelink. Through Centrepay you can choose to have a regular amount deducted from your Centrelink payment.

Minimum amount is \$25.00 per fortnight per student or more if you would like to include other fees such as SRS. Once account is in credit you can use that money for excursions.

PLEASE NOTE when filling out Centrepay form please include all student names.

5. IN PERSON:

Opening hours Monday to Friday each week between 8:00am to 3:00 pm to pay over the counter and receive a receipt immediately. You can pay either by Cash or Eftpos with Debit/Credit Card. Note: Finance is closed the last day of the term and last week of the year.

iPad Purchase Program Agreement

Student Agreement

- I am allowed to take my iPad home, and I will bring the device back to school every day.
- I will charge the device every night so that it is ready for use at school.
- I understand that I am to keep my iPad in the school supplied case at all times.
- I will not look for any information that is against the law, dangerous or offensive. If I accidentally come across something that is against the law, dangerous or offensive, I will clear my screen and advise the teacher.
- I understand that my parents/guardians and I need to report to the school if the device is lost or stolen.
- I understand that my parents/guardians will be asked to pay if the device is lost, stolen or damaged according to costs in the information provided.
- I will care for the device when it is at home and school.

Parent Agreement

- I give permission for my child to use the school device for use at home and school.
- I understand that they need to bring the device to school every day.
- I understand that they will need to charge the device every night so that it is ready for use at school.
- I understand that my child is to use the iPad case supplied by the school, always.

- I understand that if I fail to comply with the payment schedule, my child may be restricted from using the allocated device which could result in loss of content.
- I understand that I need to report to the school if the device is lost or stolen.
- I understand that I will be asked to pay if the device is lost, stolen or damaged according to costs in the information provided.
- I will help my child to care for the device when it is at home.
- I am aware that should my student unenroll from Wilsonton State High School within the agreement time, I will need to pay out the full amount to own the iPad.

Information and Communication Technologies Acceptable Use Agreement

Information and Communication Technologies (ICT) includes computers, handheld devices (iPads), printers, digital cameras, Internet and email facilities, and other associated electronic and mechanical hardware and software.

Students

I understand that the use of ICT resources at Wilsonton State High School is a privilege, which involves the acceptance of certain responsibilities. I understand and agree to the following.

I am not permitted to:

- Access, copy or distribute any material that is controversial, inappropriate, obscene or offensive.
- Download, install or transfer any software that violates copyright, intellectual property or licensing laws (this includes iOS BETA Updates on School iPads). Send, transfer or create computer viruses.
- Access the Control Panel, System Configuration, or make any changes to settings, passwords other than my own on school owned devices. Directly or indirectly access drives other than those allocated to me.
- Seek access to files or messages intended for, or belonging to, others. Use any login other than my own.
- Directly or indirectly move, delete or modify any files (other than those in my personal drive this includes removing Apps on another student's iPad). Touch another student's device without their permission.
- · Be involved with electronic or physical vandalism, harassment or bullying.
- Capture, manipulate or transmit photos of members of staff or students without their prior approval.
- Seeking to play/install Games onto iPad this includes playing games on iPads during class time.

Teachers, parents and school staff have the right to access and inspect the contents of student files and emails at any time. Random audits of student files will be carried out regularly by ICT Network Administrators. Students found to be violating this policy or any law will receive the appropriate consequences.
